Aetna Medicare Rx Plan is a Medicare drug plan and is in addition to my coverage under Medicare; therefore, I will need to keep my Medicare coverage. It is my responsibility to inform Aetna Medicare Rx Plan of any prescription drug coverage that I have or may get in the future. I can only be in one Medicare prescription drug plan at a time. Enrollment in this plan is generally for the entire year. Aetna Medicare Rx Plan serves a specific service area. If I move out of the area that Aetna Medicare Rx Plan serves, I need to notify the plan so I can disenroll and find a new plan in my new area. I will read the Evidence of Coverage document from Aetna Medicare Rx Plan when I receive it to know which rules I must follow in order to receive coverage with this Medicare drug plan.
